Call to Order, Flag Salute, Chair's Welcome

- KCDCC Chair Karl de Jong called the meeting to order at 7:00pm.
- Pierce County Democratic Chair Jeannine Mitchell led the Pledge of Allegiance.
- The KCDCC Chair gave an introductory welcome speech which is found in the Program. The KCDCC Chair recognized teachers, the Platform, Resolutions, and Bylaws Committee, and people who attended the State Convention.
- The Chair of the Candidate Support Committee Michael Martin moved, and it was seconded, and passed for Marvin Rosete to be appointed to the Candidate Support Committee.

- Delegate Jeff Sandys (32nd LD) announced that their picnic will be on July 12 from 11-4 at Lynndale Park, 18927 72 Ave W Lynnwood, WA, and the cost is \$25 for a family.
- Political Director for Congressman Smith Rebecca Bryant introduced Field Organizer Nishi (nishi –at- electadamsmith.com). She also spoke about Congressman Smith's efforts with Military Spouses Equal Treatment Act.
- Political Director for Congresswoman DelBene Erin Cheuvront introduced Field Organizers Amanda and Connor. She said they are
 offering a High School program for high-schoolers to get involved in politics.

- The "Protecting Apostates from Hate Crimes" resolution was brought out of committee, considered and passed. Delegate Christina Lee (33rd LD) had a question, which was answered.
- The "Need for Timely Transparency in Growth Management Decisions" resolution was brought out of committee, was considered and passed.
- The "Resolution in Support of Culvert Replacement" was brought out of committee, was considered and passed. Delegate Brian Gunn (31st LD) asked a question, and the answer was that this resolution was adopted at the State Democratic level.
- Delegate Christina Lee (33rd LD) and Delegate Larry Smith (46th LD) asked about the status of the resolution "Resolution for Reform of Vacancy Appointment Procedures" and specifically why it was not considered at the State Convention. Secretary Jennifer Minich read an

- Delegate Christina Lee made a motion, which was seconded, to issue payment to the Pierce County Democrats for \$300 to participate in the Washington State Fair, formerly known as the Puyallup Fair. Delegate Linda Clifton (43rd LD) asked if this motion requires suspension of the rules, and the response was that the funds are identified in the budget and pre-approved in the budget, so no suspension is needed. KCDCC 3rd Vice Chair Roger Crew brought attention to Bylaw Section 10.4. Delegate Larry Smith (46th LD) added that it is in order because it is a political committee. Resolution Opposing Implementation of the Social Security Administration's Proposed "Vision 2025"

WHEREAS the Social Security Administration (SSA) published, on March 10, 2014, a proposed "Vision 2025" plan for making online self-service its primary method of serving its clientele, eliminating direct service to clients except in very limited circumstances, and farming out much of its workload to outside organizations while eliminating its traditional full-service field offices; and

WHEREAS outside organizations serving SSA clients would be allowed to charge for services which those clients have already paid for through their FICA taxes; and

WHEREAS SSA field offices served a record 43 million visitors in 2013, and call volume to SSA's 800 number created unprecedented delays in contacting an agent; and

WHEREAS "Vision 2025" would force most U.S. workers, their families and their survivors to fend for themselves in trying to obtain benefits they have worked for all their lives; and

WHEREAS, given that SSA field office employees get 17 weeks of training and only become fully proficient in three to four years, it is patently unrealistic to expect SSA clients (who have no such training at all) to be able to navigate the system in just a few minutes online; and

WHEREAS a mandate of online enrollment essentially requires use of a computer, thus stripping SSA access and benefits away from seniors and other vulnerable populations, including people for whom English is not a first language, people who do not have and do not know how to use computers, and people with such disabilities as early-onset Alzheimer's;

THEREFORE, BE IT RESOLVED that we urge our federal lawmakers to decisively reject "Vision 2025," and instead to mandate increased funding for SSA field workers and traditional full-service field offices; and

BE IT FURTHER RESOLVED that copies of this resolution be sent to our U.S. Senators and Congressmembers, together with a request for a response as to the specific actions they will take to implement its intent, and how soon such actions may be expected to occur.

Sexual Assault: Not a Laughing Matter on Our Network

WHEREAS sexual harassment in the military, frequently accompanied or followed by sexual assault, has become a serious and persistent problem, damaging to troop cohesion and morale; and

WHEREAS, according to <u>Defense Department statistics</u>, sexual assaults rose more than 30% in a recently completed two-year period, from a shocking 19,300 in 2010 to an appalling 26,000 in 2012; and

WHEREAS the American Forces Radio network broadcasts news and commentary, including "The Rush Limbaugh Show," to our military personnel in the United States and abroad; and

WHEREAS the Rush Limbaugh Show not only consistently exhibits tolerance for sexual harassment, it treats it as sport and encourages it – as exemplified by Mr. Limbaugh's broadcast correlations of breast size and IQ, his suggestions that women enjoy sexual harassment and that men could more effectively harass women by asking them to have their breasts "stop staring at my eyes"; and

WHEREAS Mr. Limbaugh, in his demonstrably misogynistic program, has swung between celebrating sexual harassment and denying its existence, and gone so far as to joke about rape itself; and

WHEREAS it is irresponsible for taxpayer dollars to be used to fund the broadcast to our troops of radio programs that advocate, make light of, or express tolerance for sexual harassment and rape;

THEREFORE, BE IT RESOLVED that we call on the U.S. Department of Defense to remove the Rush Limbaugh Show from our taxpayer-funded American Forces Radio; and

BE IT FURTHER RESOLVED that this resolution be sent to Defense Secretary Chuck Hagel and to our two U.S. Senators, Patty Murray and Maria Cantwell.
