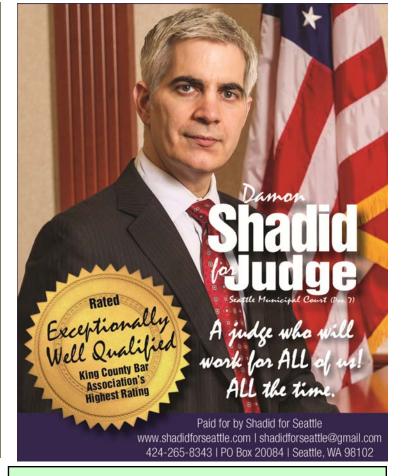

King County Democratic Central Committee (KCDCC) Executive Board Meeting Minutes

September 23, 20147:07 - 9:20 pm

Call to Order, Flag Salute, Chair's Welcome

- KCDCC Chair Karl DeJong called the meeting to order at 7:07pm.
- Delegate Aaron Corn (37th Legislative District) led the Pledge of Allegiance.

Approval of the Agenda

- A motion was made and seconded to approve the agenda. KCDCC 2nd Vice Chair Ken Taylor made a motion, which was seconded by 33rd Legislative District (LD) Chair Omaha Sternberg to add Vice Chair reports to the agenda. 34th LD Chair Marcee Stone-Vekich offered an amendment to add it before the LD reports, which was seconded. The agenda was passed as amended.
- The Chair of the 37th LD Michael Wolfe rose for a point of personal privilege to congratulate the KCDCC Parliamentarian Scott Forbes for passing the Bar Exam. KCDCC gave hearty congratulations.

Approval of the July Minutes

• A motion was made, seconded, and passed unanimously to approve the July minutes. There was no August meeting.

Vice Chair Reports

- 2nd Vice Chair Ken Taylor introduced KCDCC Intern Tony Buhr, and they provided a report about the cancelation of the November gala
 they had been diligently working on.
- 3rd Vice Chair Roger Crew spoke. Delegate Christina Lee (33rd LD) brought up a concern that Roger is working on addressing
- 4th Vice Chair Devon Abdallah reported that the Secretary of State's Office has agreed to translate voter registration forms and there should be first drafts within the 1st quarter of 2015.
- The KCDCC Chair announced that the Chair of the 37th LD Michael Wolfe is the new Chief of Staff. The KCDCC State Committeewoman Ann Martin asked about this role, and the answer provided was that this position will assist the KCDCC Chair in communications as well as in situations in which he cannot be present in two places at the same time.

Legislative District and Young Democrats Reports

- Chair of the 33rd LD Omaha Sternberg reported on the educational forum. The meeting in October will be a Get Out the Vote meeting.
 There will be an election night event on November 4th.
- The Chair of the 37th LD reported on their Get out the Vote sample ballots.
- Chair of the 30th LD Tim Burns reported on their support of the Senate campaign with help from the 46th LD. There will be a showing of Citizen Koch on September 30th at the Century Theatre at Seatac Mall.
- Delegate Phillippa Kassover (46th LD) announced the Chair of the 46th LD's birthday. The 46th LD had an issues forum. They hold a
 weekly phone bank.
- The Chair of the 34th LD announced that their fundraiser raised \$14,000. Their LD is phone banking at the Machinist Hall with

Organizing for Washington and is walking for Shari Song.

- Delegate Janet Way (32nd LD) announced that Senator Chase's mother passed. There was a Take Back the Senate Karaoke night that raised \$3,000.
- Chair of the 43rd LD Scott Forbes reported on their efforts to host a Pasta for PCOs event on October 11th.
- Chair of the King County Young Democrats Betsy Walker announced that there will be a Murder Mystery night on Saturday, October 18th, "Who Killed Jaxon Ravens?"

Political Director Reports

- Congresswoman DelBene's staff member Kate Nolan reported on their campaign and calendar of events.
- Political Director for Congressman Smith Rebecca Bryant reported on the Salmon Bake on Sunday from 5-6:30pm as well as other campaign events and activities.

Program on Universal Pre-K in Seattle Proposition 1A and 1B

- There will be two questions. The first is whether either of these measures should be enacted, and the second question is a vote on which one, Proposition 1A or 1B. Prop. 1A is Yes for Early Success, and Prop. 1B is Quality Seattle Preschool. They are requesting a position on the first question.
- President of the American Federation of Teachers Washington Karen Strickland and Emerald Walker with the Yes For Early Success campaign spoke about the benefits of early education, the Yes for Early Success campaign, and Proposition 1A.
 - State Committeewoman Sarajane Siegfriedt (46th LD) asked if it would be posted publicly if supported, and the response is that there is an endorsements section on the webpage. A Delegate from the 1st LD asked why they were not asking for an endorsement, and the response was they are asking for a position on the first question.
- City of Seattle's Office of Early Learning's Sonja Griffin, City of Seattle Mayor's Office's Austin Miller, and Seattle City Councilmember
 Joe McDermott spoke about the benefits of Proposition 1B. This proposal is a four-year demonstration program, serving 2,000 children
 in one hundred classrooms by 2018. 1B includes a funding source. They are requesting a position on both questions.
 - Delegate Christina Lee (33rd LD) asked about what 'near universal' meant. She and the KCDCC State Committeewoman asked
 where the funding would come from after the fourth year. There is a levy that expires, and it could be part of a new levy vote.
 This is not a universal program, but rather a pilot program.
 - The KCDCC 4th Vice Chair asked about curriculum choice and those children with limited English proficiency. The answer was that dual language pre-school would be part of the program. Delegate Phillippa Kassover (46th LD) asked about curriculum, and Delegate Larry Smith (46th LD) asked whether the curriculum would tie into Common Core. No curriculum has been selected yet, and Race to the Top funding is not driving this program.

Endorsements Committee

- Endorsements Committee Chair Michael Maddux provided a report.
- A recommendation to endorse the Seattle Transportation Benefit District Proposition 1 was reported out of Committee and was passed unanimously.
- A recommendation to endorse Seattle Proposition 1B was reported out of Committee.
 - The 3rd Vice Chair rose for a Point of Order to ask if the first question could be addressed before 1A or 1B. The KCDCC Chair ruled out of order because 1B is the motion brought out of the Endorsements Committee. The Chair of the 37th LD asked if the

first question was considered in Committee, and the Endorsements Committee Chair answered that the Committee's recommendation is Prop. 1B. The Chair of the 34th LD asked who participated in the Committee process, and the Endorsements Committee Chair's answer was that 14 members participated. Delegate Phillippa Kassover (46th LD) asked about speakers for and against.

- The KCDCC State Committeeman Javier Valdez spoke in favor and Delegate Tara Gallagher (43rd LD) spoke in opposition of 1B. The Chair of the 43rd LD answered the Chair of the 37th LD's question that the 43rd LD has endorsed Prop 1B. The vote failed.
- Delegate Brian Gunn (31st LD) made a motion requiring a 60% threshold to endorse Mike Sando, and it was seconded by the 3rd Vice Chair. Delegate Brian Gunn (31st LD) mentioned that the 31st LD endorsed Mike Sando. The vote passed to endorse 20-2, with 12 abstentions.
- A motion was made and seconded to consider a Yes answer to the first question in Prop 1A and 1B, which is whether either of these measures should be enacted. This vote passed 29-10.
- The Chair of the 37th LD asked who else is running who submitted for consideration, and the 3rd Vice Chair went through the list.
- The Chair of the 30th LD made a motion, which was seconded and passed, to eliminate the Legislative Action Committee report.
- The 4th Vice Chair made a motion, which was seconded and passed, to eliminate the Voter Outreach Committee report.
- State Committeewoman Sarajane Siegfriedt (46th LD) made a motion to take no position on Prop 1 (1A/1B) at all. Roger Crew rose to explain that to do nothing is status quo, and a motion must change the status quo. The KCDCC Chair ruled the motion out of order.
- The KCDCC State Committeewoman rose to make a motion to endorse Yes to the first question of Prop. 1 (1A/1B) but to not take a position on either 1A or 1B. The first question is whether either of these measures should be enacted, and the second question is a vote on which one, Proposition 1A or 1B. Prop. 1A is Yes for Early Success, and Prop. 1B is Quality Seattle Preschool. State Committeewoman Sarajane Siegfriedt (46th LD) and Delegate Mary Wallon (36th LD) spoke against. The Chair of the 33rd LD rose to read a letter that was sent out. Delegate Layne Bautista (34th LD) spoke in favor. This vote passed 29-10.

Treasurer's Report

- Treasurer David Fish reported a balance of \$2,590 and mentioned he emailed out the financial report. There has been a donation toward a fundraiser as well.
- Delegate Christina Lee (33rd LD) brought up her concern that not all people have email access and asked how much money was needed to operate for the remainder of the year. State Committeewoman Sarajane Siegfriedt (46th LD) asked about the reasonable cost of reorganization. The Treasurer answered \$500.
- The KCDCC Chair thanked Candidate Support Chair and Chef Marvin Rosete for preparing dinner, which is available in the back of the hall.
- The KCDCC State Committeewoman made a motion, which was seconded to eliminate the State Committee report. The Chair of the 37th LD made a motion to amend the language to include but limit the Platform, Bylaws and Resolutions Committee report to 5 minutes. This motion passed.

Finance & Development Committee

- The 1st Vice Chair Christina Lewis reported that the Gala was cancelled and that a Cocktail Party event was planned for November 8th.
- The 2nd Vice Chair made a motion and it was seconded by the Chair of the 33rd LD to continue the Gala or at least merge the two events. The budget for the event is \$1,000 for the venue and \$3,200 total for the event. Even in the worst-case scenario, there would be no debt. The Treasurer reported that there is not sufficient money in the account.

- The 3^{rd} Vice Chair made a motion and Delegate Tara Gallagher (43^{rd} LD) seconded it to extend the meeting ten more minutes. This motion passed.
- The 2nd Vice Chair reported on the hard work Intern Tony Buhr put into planning this event.
- Delegate James Langston mentioned that two fundraisers were hired and neither was successful or approved by the members. The Treasurer corrected the record that the members passed the budget which included funds for hiring a fundraiser.
- The Chair of the 37th LD said that he reached out to the Gala planners but didn't feel the progress was sufficient to proceed, and they have \$6,000 pledged to support the Cocktail Party. The 2nd Vice Chair asked if he and Mr. Buhr can have a seat in the planning of the Cocktail Party to incorporate their Awards ceremony.
- Delegate Tara Gallagher (43rd LD) asked about the costs involved in the Cocktail Party. The response was that the costs are for \$600 for food and beverages, and \$6,000 is pledged for the event. The Secretary Jennifer Minich asked why we cannot do both events. Delegate Jodi Riker (30th LD) asked why the \$6,000 can't be used to sponsor both events.
- The motion was re-stated with more specific language to merge both events, locate it at the WAC, and include the elements Tony Buhr has put effort into. The Chair of the 30th LD amended it to include the date of November 8th, which was seconded. This motion as re-stated and amended passed.

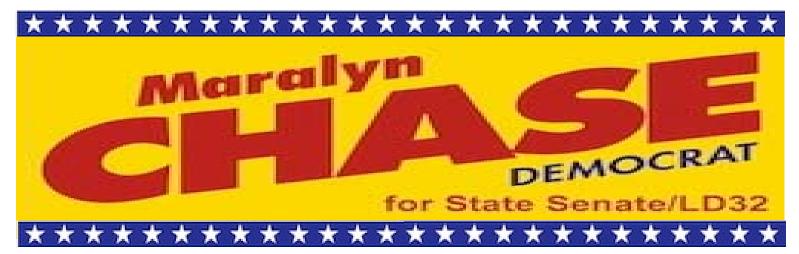
Platform, Resolutions, and Bylaws (PRB) Committee

- The KCDCC State Committeewoman gave the report on behalf of the Committee. Two resolutions were submitted for consideration
 with recommendations for passage.
- A Resolution Opposing Seattle Housing Authority Rent Increases was reported out of committee with a recommendation to pass. The
 Chair of the 37th LD spoke in favor of this resolution and introduced John Fox with the Seattle Displacement Coalition who also spoke in
 favor of this resolution. 4,600 households would be affected by the rent increases. The resolution passed unanimously.
- A Resolution Opposing Religious Guidance at Party Meetings was reported out of committee with a recommendation to pass. The
 KCDCC State Committeewoman reported that this resolution failed at the State Committee meeting. Delegate Toby Thaler (43rd LD)
 and Delegate Tara Gallagher (43rd LD) spoke in favor of the resolution. The Chair of the 33rd LD and State Committeewoman Sarajane
 Siegfriedt (46th LD) spoke in opposition to the resolution. The vote failed 21-12.

Adjourn

A motion was made, seconded, and passed to adjourn at 9:20 pm.

REORGANIZATION

OCTOBER 28, 2014

Calling of LD Biennial Reorganizational Meetings: As provided in RCW 29A.80.061, the KCDCC Chair shall, within 45 days after the statewide general election in each even-numbered year, for the purpose of electing a Legislative District Chair for each district located primarily within the County, issue calls for separate meetings of all elected precinct committee officers in each such district. As provided in Article IX.C of the Washington State Democratic Party (WSD) bylaws, each such meeting shall be scheduled to occur in the December or January immediately following the even-year general election and shall serve as the organizational meeting of the respective Legislative District Organization, in which certain officers in addition to the Chair are elected. Each such meeting shall be conducted in accordance with WSD and KCDCC rules.

* The Temporary Meeting Chair may customize proposed agenda items as warranted, for example, to expand "Election of All Other District Officers" into an actual list of officers. Moreover, if a District Credentials Committee is actually needed, that committee's report must occur prior to the first election in which non-PCOs are allowed to vote (see Rule 5).

Guest speakers may be introduced and/or allowed speaking privileges at the discretion of the Temporary Meeting Chair or newly elected District Chair.

Calling of County Committee Biennial Reorganizational Meetings: As provided in RCW 29A.80.030, sometime after the general election in each even-numbered year but before the 2nd Saturday of the following January, the PCOs of each county meet to elect new officers for their county central committee. As provided by Article VIII.C of the WSD bylaws, these officers shall include the Chair, (1st) Vice-Chair, and male and female representatives to the State Democratic Central Committee.

Proposed Rules for Legislative District Reorganizational Meetings

- 1. The meeting shall be called to order by a Temporary Meeting Chair, who shall be either the KCDCC Chair or his/her designee. The Temporary Meeting Chair
 - a) shall have appointed a Credentials Committee to administer sign-ins for the District's Precinct Committee Officers (PCOs);
 - b) shall also appoint, for the meeting, a Secretary, Parliamentarian, Sergeant-at-Arms, and Tally Committee; and
 - c) shall preside until a District Chair has been elected.
- 2. After adoption of the Agenda and meeting Rules, the body shall adopt bylaws for the District Organization. Bylaws adoption may be postponed, either to later in the reorganization meeting or to a subsequent meeting of the organization; however, until such time as the District Organization adopts bylaws for the 2015 -2016 biennium, its existing bylaws are acknowledged as remaining in effect.

Regardless of whether bylaws adoption is postponed, the body may adopt standing rules for the District Organization.

- 3. Only District-resident PCOs elected at the August 5, 2014 primary—including those elected by virtue of being the only candidate to file in a precinct— shall be eligible to vote on the adoption of bylaws or in elections for
 - a) District Chair;
 - Vice-Chair (i.e., the office considered to be *the* Vice Chair of the organization for WSD purposes, even if the actual title is different; e.g., "First Vice-Chair" or "Vice-Chair for Pierce County");
 - c) State Committeeman and State Committeewoman;
 - d) Representatives and Alternates to the KCDCC Executive Board, including the Vice-Chair for King County in those districts where such office exists and differs from the Vice-Chair of the organization per clause (b) above;
 - e) Representatives to other county central committees, as applicable;
 - f) Representatives to congressional district organizations, as applicable.

Proposed Rules for the KCDCC Reorganizational Meeting

- The 2014 County Chair shall appoint a temporary chair for the initial phase of the reorganization meeting, and a Credentials Committee to administer sign-ins for King County's Democratic Precinct Committee Officers (PCOs).
- 2. The temporary chair shall:
 - a) call the meeting to order and appoint, for the meeting, a Secretary, Parliamentarian, Sergeant-at-Arms, and Tally Committee; and
 - b) preside until the election of a County Chair for the 2015-2016 term.
- 3. Only Democratic PCOs residing in King County and elected at the August 5, 2014 primary including those elected by virtue of being the only candidate to file in a precinct shall be eligible to vote.
- 4. Anytime after adoption of the Agenda and meeting Rules, the body may adopt bylaws. In the event no new bylaws are adopted at the meeting, the existing KCDCC bylaws [as amended March 25, 2014] are acknowledged as remaining in effect.
- 5. Unless new bylaws are adopted, officer elections shall proceed in the order specified in Sec. 5.1 of the existing bylaws.
- 6. Pursuant to RCW 29A.80.030, only persons of gender opposite to that of the newly elected County Chair may be nominated for 1st Vice-Chair. Under the existing bylaws, no more than two of KCDCC's four vice-chairs may be of the same gender as the Chair.

- 4. Officer elections shall proceed in the sequence specified by District rules (as defined in Rule 9), which, in turn, defaults to the order the offices are first listed in the District Organization's bylaws, so long as
 - a) the District Chair is elected first, and,
 - b) if District rules fail to provide for election of one or more of the officers listed in Rule 3 as required by WSD or county committee bylaws, those missing elections shall be held, in the order specified by Rule 3, immediately after the election for the last required office provided for.
- 5. If there exist officer positions or subsequent business on which non-PCO members of the District Organization may vote, and such voting members exist (even if only potentially via renewal of membership with immediate voting rights pursuant to District rules):
 - a) a District Credentials Committee to process membership renewals and issue credentials to eligible non-PCO members present shall be formed as per District rules, or, if District rules do not address such matter, shall be appointed by the District Chair upon his/her election; and
 - b) upon completion of the last officer election prior to those officer elections and subsequent business that non-PCO members may vote on,
 - i. the meeting shall, if necessary, recess to allow completion of membership renewals and credentialing for all non-PCO members present at that time, following which
 - ii. the District Credentials Committee shall report on the non-PCO members, which shall include the total number of such members credentialed;

provided, however, that credentials issued to non-PCO members must be visually distinct from those issued to PCOs, and any ballots issued to non-PCO members must be visually distinct from those used for elections where only PCOs are allowed to vote.

- 6. The process for nominating and electing all positions shall include the following:
 - a) Call for nominations.
 - b) Closing of nominations.
 - c) One-minute nomination speech for each candidate, in which the order of speeches is determined by the order of nomination
 - d) One-minute seconding speech for each candidate.
 - e) Speakers for all races may be PCOs, candidates, or other residents of the Legislative District willing to publicly declare themselves as Democrats.

- 7. The process for nominating and electing each position shall include the following:
 - a) Call for nominations. Each nomination shall require a second.
 - b) Close nominations.
 - c) Two minutes of speeches on behalf of each candidate, in the order of their nomination, delivered by candidates, PCOs, and/or other residents of King County willing to publicly declare themselves as Democrats.
- 8. A simple majority is required to elect a candidate to any KCDCC office.

In any inconclusive balloting round with three or more candidates, the candidate receiving the fewest votes shall be dropped, except to the extent that candidates withdraw voluntarily or the body votes to reopen nominations before the next round.

Elections require written ballots for as long as they are contested. Uncontested candidates may be elected by acclamation.

Written ballots need not be signed. Instead, pursuant to WSD Charter VII.G.2, there shall be a mechanism to ensure the eligibility of those who cast ballots; e.g., a check-off list, sign-in-sheet, or ballot receipts.

- 7. Uncontested candidates may be elected by acclamation. For contested elections, a written ballot is required.
 - When PCOs vote for organizational officers (e.g., chair, vice chair, secretary, treasurer, state committeepersons), they do not have to vote by signed ballot provided that there is a mechanism to ensure the eligibility of those who cast ballots; e.g., a check-off list, sign-in-sheet, or ballot receipts. (WSD Charter VII.G.2). If District rules do not specify whether signed ballots are required in this case, this decision shall be made by the body prior to election of the District Chair.
- 8. Persons approved by the body to be appointed to fill a PCO vacancy do not actually become PCOs until appointment by the County Chair, and no such appointment shall be effective prior to adjournment of the reorganization meeting. This does not preclude such persons being treated as members of the District Organization immediately upon approval if District rules so allow.
- 9. District rules, i.e., the District Organization's bylaws, special rules of order, standing rules, and designated parliamentary authority—or, lacking such, the latest edition of Roberts Rules of Order Newly Revised—shall govern all other aspects of the meeting.

COMMITTEE REPORTS

Platform, Resolutions, and Bylaws Committee

Your Platform, Resolutions and Bylaws Committee has prepared this month, pursuant to its mandate as set forth in KCDCC Bylaws §10.7 (3rd bullet), a set of proposed rules (and a proposed agenda) for the upcoming round of LD reorganization meetings. Links thereto appear elsewhere in this newsletter. These documents were drafted to assure our LDs' compliance with the applicable controlling authority found in RCW 29A.80.061, State Party Bylaws IX.B and IX.C, and KCDCC Bylaws §§ 13.1-13.3, and we are now presenting them for approval by the KCDCC Executive Board. (As you may recall, each such LD re-org is to be initially chaired by a KCDCC representative appointed by the County Chair.)

Aware that we were engaging in such a task, County Chair Karl deJong asked us to draft a counterpart set of proposed rules-and-agenda for KCDCC's own re-org — scheduled to occur on Saturday, Dec. 6. (Under Bylaw §5.4, 4th bullet, issuance of such rules-and-agenda is a prescribed responsibility of the Chair.) In the knowledge that KCDCC's own re-org must comply with RCW 29A.80.030, State Party Bylaws VIII.B and VIII.C, and KCDCC's own Bylaws §§ 5.1 and 6.1, we did so; and links to this document also appear elsewhere in this Newsletter.

We are deeply indebted to KCDCC 3rd Vice-Chair Roger Crew for both his research and dogged draftsmanship on both sets of Rules and agendae.
