- 1. How will you supervise the lower courts in your district?
- 2. What ideas do you have to make our judicial system more open, transparent, and responsive?

#### 2024 Superior Court Questions (also applies to District Court)

- 1. What conditions compel you to sentence below the minimum standard?
- 2. Fines and fees present an obstacle for many people seeking justice. How can you address that issue?
